

From Data Citations towards effective Valorization and Tracking of Data Reuse

Abstract. The principles that enabled the web of documents to flourish based on the resource description framework have so far not been applied to data [1]. In the past, data has been made available as raw dumps in various formats not sufficiently linked to associated elements. Best practices for linked data based on unified resource identifiers lead to the connection of data from diverse domains [2]. At present, digital research objects are more commonly published and assigned persistent identifiers [3], but even minimal FAIR practices differ vastly across research contexts (as does data sharing and reuse) [4]. Citations to digital research objects, upon reuse, are not common practice [5]. If data are cited at all, this mostly happens in an informal manner [6], by reference to the associated scholarly article, by indication of the underlying web resource hosting the published data, or not at all. Making research objects FAIR and a subsequent equitable reuse imply a cultural change where researchers play an important role by serving as advocates for open science principles and by adopting a number of best practices [7]. Data publication infrastructures, in particular associated metadata, provide an important pathway for enabling FAIR data reuse by integrating scaffolding features [8]. Additionally, in order to incentivize data sharing, the data index has been proposed as an author level-metric [9]. However, as with other metrics (h-index, Impact Factor), the social dynamics of attention in academia make for highly skewed patterns of recognition, known as the Matthew Effect [10,11]. Although the Matthew effect can have positive effects in terms of steering researchers' attention [12], it also results in a stratified distribution of opportunities in academia [13], and has been shown to be at play at the level of article citations [14], countries [15], institutions [16], departments [17], and journals [18]. With respect to data citation, parallel dynamics can be expected. However, unless reused data have been cited properly, no data citation link for its reuse can be created.

The community-driven OpenAIRE Graph endeavours to link and contextualize all research outcomes integrating heterogeneous data sources and providing relationships among them [19]. Unfortunately, data reuse is not comprehensively captured due to lacking or additional citation options and knowledge acquisition limitations [20,21]. The initial strategic approach of EOSC also anticipated to integrate a framework that would allow for unique identification, citing, avoiding duplication and tracking of impact through a service concept to generate, resolve and validate PIDs (systems) including a policy framework for PIDs for research entities [22]. This concept would need to be further pursued to pave the way for valorizing data provision and create fair data reuse. Recently, a machine-readable data reuse information tag (DRI) was proposed to enable equitable data reuse for web resources apart from repositories [23]. This tag would include information on the associated open researcher and contributor ID (ORCID) providing contact information to data consumers. In general, data reuse would need to be commonly traced and

linked to data creators - such as ORCID - and mapped in a similar manner to published research output. Linking of PIDs as it is common for scholarly articles, e.g. via Crossref [24], would need to be standard practice for indexing and tracing all published digital research objects making data re-findable.

In conclusion, we propose a multilevel approach to valorising and tracking data reuse: (1) observing Matthew effects in the transition to open science practices, with special attention to data citations. (2) Introducing workflows for capturing published digital records other than scholarly literature based on various PIDs and informally cited data. (3) An extension to existing workflows enabling automatic updating of researchers' ORCID records upon published research objects' reuse.
